- This application must be submitted via email by May 26th, 2017 to info@eelriverbrewing.com
- We will contact you no later than June 7th if you have been accepted.
- There is a \$100 charge to sell your food at Summer in the Triangle
- The number of food vendors is limited to 3 in addition to Eel River Brewing pub fare & oysters
- To avoid competition, only one major food item is allowed per vendor
 - *Example: If you are serving Tri-Tip Sandwiches, you will be the only one at the event serving Tri-Tip Sandwiches.*
 - *Side dishes such as fries, chips and drinks do not count as a major menu category and several vendors may have these items available.*

IF YOU ARE ACCEPTED TO PARTICIPATE:

- You have 10 days to get a temporary food permit from the Humboldt County Environmental Health Department or we may give up your spot to another vendor.
- You have 10 days to mail in your \$100 application fee to:

- Expected attendance between 300-500 people
- There are NO animals allowed at this event
- Typical space is 10' x 10'. If you need more room tell us in the special requests space.
- You must provide your own tables, tent, chairs, panels, electricity and/or shade.
- You will be contacted on June 23rd with space assignment.
- If you have a preference or need special accommodations indicate them in the special requests section and someone will contact you. Do NOT wait until the day of the event as we will not accommodate at that point.
- Set-up can start as early as 9:00 a.m. but must be complete by 12 pm
- Please do not pack up and leave until the event is finished.
